The general fund balance is \$13,129.41. The capital fund balance is \$70,233.62. The minicourt balance for all 8 minicourts is \$23,183.87. Our total bank balance is \$83,363.03.
- B. 2016 Budget. Our 2016 budget is \$23,276.00 as is our expected income.
